The Regulation of Prevention Services indicates that companies which develop activities with their own resources will have to submit their prevention system to be checked by an auditor or external evaluator.

The audit must be carried out within twelve months from the time the preventive action plans become available. It must be **repeated** every **four years**. This excludes activities included in Annex I of the RSP, in which the deadline is every two years. Current legislation will apply. Information received from employees will be taken into account.

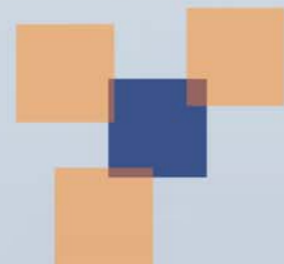
